## **Jr/YR CLINIC RIDERS**

Riders must submit an online application to be considered for this clinic. This clinic features two days of riding lessons and theory sessions. Riders between 14-21 years of age will be given priority. Riders ages 12-14 competing in FEI Pony or FEI Children classes may also apply. U25 riders will also be given consideration as space permits. Riders must have a USDF Participating or Life Membership. They must also have a USEF Active Competing Membership.

## **YOUTH OUTREACH CLINIC RIDERS**

Riders must submit an online application to be considered for this clinic. This clinic features one day of riding lessons and one day of auditing. On Saturday, the Youth Outreach Clinic participants will observe the Jr/YR Clinic riding sessions at Pirouette Enterprises facility, sitting together as a group as their clinician leads the discussion for each session. They will also participate in the theory sessions with the Jr/YR clinician. On Sunday, each Youth Outreach Clinic participant will ride in a 45-minute session with their clinician at River Run Equestrian Training Center facility. Interested riders must submit an online application. Riders must be 10-21 years of age, and must be able to complete a Training Level test. Riders must be current USDF Participating or Group Members.

## **AUDITORS**

Pre-registration is strongly encouraged to facilitate planning. Walk-in auditors should plan to bring a chair, if possible. If you pre-registered to audit, your name will be on the registration list provided to the organizer and a pre-printed name tag will be available for you at the clinic which will serve as your ticket. If you walk in, there will be registration forms and blank name tags at the registration desk.
